**ORDER**  
**11.12.2024**

Part submissions addressed on behalf of the appellants in relation to SGCM-3 by Ld. counsel Mr. S.S Pandey.

2. Court notice be issued to the all the counsel representing the appellants in all the matters listed today with copy of this order.

3. Vide orders dated 22.04.2024 and 21.08.2024, the presence of the appellants has been exempted through counsel whose Vakalatnamas are on the record. Vide order dated 21.08.2024 when the matter had been taken up for directions, it was directed to the effect:-

*"2. The parties are directed to ensure that the written submissions, if any, sought to be filed by them be filed within a period of three weeks. The original records qua the court-martial proceedings be also produced by the respondents, as directed vide order dated 22.04.2024, three weeks before the next date of hearing with a copy thereof being placed on record and the Registry shall report the compliance of the directions made hereinabove. The dates of hearing 22.08.2024 and 23.08.2024 in terms of proceedings dated 22.04.2024 and in terms of proceedings dated 07.02.2024 are thus cancelled. The presence of applicants continues to be exempted through counsels representing them whose vakalatnama is on the record till further directions."*

4. The dates of hearing 25.11.2024 to 29.11.2024 were scheduled vide order dated 21.08.2024 at 2:15 p.m. Vide order dated 16.10.2024, the matter was taken up through the Hybrid Mode directing to the effect:-

*"The matters at serial Nos. 3-65 listed for the day are fixed for hearing from 25.11.2024 to 29.11.2024 at 2:15 P.M. 2. The matter has been taken up for directions today through the Hybrid Mode."*

4. The dates of hearing 25.11.2024 to 29.11.2024 were scheduled vide order dated 21.08.2024 at 2:15 p.m. Vide order dated 16.10.2024, the matter was taken up through the Hybrid Mode directing to the effect:-

*3. It is directed now to the effect that the proceedings from the date 25.11.2024 to 29.11.2024 in all the said matters shall be taken up from 11:00 A.M. onwards till 4:30 P.M. on each of the said dates and all other matters in Court-2 on the said dates 25.11.2024 to 29.11.2024 other than the Nyoma Matters listed today for directions shall not be listed for hearing on the said dates. Ample advance notice has thus been given vide the present proceedings to either side to ensure that the hearing takes place effectively on the abovementioned dates i.e. 25.11.2024 to 29.11.2024 from 11:00 A.M. onwards.*

*4. Copy of this order be also served on all the counsel for the both sides through e-mail so that effective proceedings are conducted on the dates fixed."*

5. The proceedings dated 16.10.2024 have made it amply clear that advance notice has been given to all the parties to ensure that the hearing takes place effectively on the dates 25.11.2024 to 29.11.2024 from 11 am onwards. Copy of this order was also directed to be served to all counsels for either side through e-mail so that the effective proceedings were conducted on the said dates.

6. After the hearing took place from 25.11.2024 to 29.11.2024, after the proceedings of 29.11.2024 the matter has been taken up for hearing from 03.12.2024 onwards through the Hybrid Mode on every Tuesday and Wednesday. The Bench constituted for hearing the NYOMA matters was constituted vide directions dated 05.09.2023 of the Hon'ble the Chairperson comprising of Hon'ble Ms. Justice Anu Malhotra, Member(J) and Hon'ble Lt Gen C.P. Mohanty, Member(A).

7. Vide directions dated 02.12.2024 of the Hon'ble the Chairperson till further orders, the Roaster of Court-2 for the days of Tuesday and

Wednesday comprises of Hon'ble Ms. Justice Anu Malhotra, Member(J) and Hon'ble Lt Gen C.P. Mohanty, Member(A) i.e. of the two Members who form the Bench constituted to hear the NYOMA matters. It is observed that there is no adequate representation of the appellants and the respondents apart from representation by the learned counsel Mr. S.S. Pandey, Advocate and Gp Capt Karan Singh Bhati, Sr. CGSC and sometimes representation on behalf of Mr. I.S. Singh and sometimes presence of Dr. V.S. Mahndiyan and Mr. Shyam Narayan. There was representation by Maj Anand Kumar once on behalf of the appellants.

8. In as much as the hearings have to be effectively conducted without *demur*, it is essential that there is adequate representation of the appellants and the respondents for the hearings fixed on every Tuesday and Wednesday till further directions dated 02.12.2024 of the Hon'ble the Chairperson in the NYOMA matters. As the presence of the appellants has been exempted only through the learned counsel whose Vakalatnamas are on the record, it is imperative that the appellants are represented by the learned counsel for the dates of hearing falling which action in accordance with law to ensure presence of the appellants would have to be taken. Copy of these directions be emailed to all the counsel representing the appellants and the respondents.

9. The respondents are directed to submit the chart detailing the sentence already undergone by all the appellants as per the findings of the Court martial in the all the SGCs. The dates of release of the appellants be put forth by the appellants through documents.

10. The correct list of the persons tried the SGCMs 1-9 be submitted by the authorized representative of the respondents vide an affidavit.

11. It is made clear that the attendance of only the learned counsel present physically or through Video conferencing would be recorded in the proceedings. Copies of the Court of Inquiry(COI) be submitted during the course of the day by the respondents and directions dated 25.11.2024 onwards be complied with accordingly.

12. Re-list the matters for hearing as 'Part Heard' on 17.12.2024 through the 'Hybrid Mode'.
