### **Publication of Notice in the newspapers:**

The Company has informed that, on the basis of the Register of Members and the lists of Beneficial owners made available by the Depositories viz., Central Depository Services (India) Limited (CDSL), the Company has dispatched the Notices convening the AGM 24/11/2023 and onwards, by ordinary post to Members and the same was hosted on the website of the Company.

The public advertisement with respect to dispatch of Notice and conducting of remote e-voting was published regional Language in Lokmat on 24/11/2023.

### **Cut-off date:**

The Voting rights were reckoned as on December 06, 2023, being the Cut-off date for the purpose of deciding the entitlement of Members for remote e-voting and e-voting at the AGM.

### **Remote E-voting:**

Company had made available remote e-voting facility to its Members and the remote e-voting period commenced at 10.00 a.m. on Saturday, December, 09, 2023 and ended at 5.00 p.m. on Friday, December 15, 2023, thereafter, it was blocked by CDSL for e-voting. Members were required to cast their votes electronically conveying their assent or dissent in respect of the Ordinary businesses, on the e-voting platform provided by CDSL.



**Process of scrutiny and counting of votes:**

After voting, I unblocked the results of the remote e-voting on the e-voting platform and downloaded the results.
